### RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT AND PARENTAL CONSENT

By signing this form and in consideration of participating in gymnastic events, I, for myself and as the minor's parent and/or legal guardian understand the nature of this activity and participation involves risks of serious bodily injury, including permanent injury, paralysis and death which may be caused by my or the participant(s) actions or by the negligence of the "releasees" named below; and that there may be other risks not known to me or foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages that I or other listed individuals incur as a result of participating in the activity. If we believe the event conditions to be unsafe, we will immediately discontinue participation in the activity.
